Prerequisites: MATH 3013 Linear Algebra, and MATH 2163 Calculus 3.

Homework: Homework(including computing project) will be assigned regularly(total 5 homeworks) and collected during the class. The due date for each homework will be announced in the class.

Attendance: Attendance of lectures is mandatory, but roll will not be taken every class. You are responsible for knowing the material, assignment, etc. presented in the class and the date of the exams announced in the class. The class schedule including the exam date is subject to change.

Talking among the students(using cell phone, reading newspaper etc) is not allowed in the class. All questions must be addressed to the instructor.

Exams: We will have one in class midterm(50 pt) and 1 final(100). (time and date will be announced in class)

Conflicts: If you will miss an exam, let me know as soon as you know(and in advance unless absolutely impossible). Depending on the reason, I may be able to give you an exam early or late, though I won't guarantee it. I require proof of the reason for your absence(e.g., a doctor's note, proof of involvement in an OSU-sponsored activity, etc).

Grading - There will be no makeup exams. Your grade will be based on 50 for the midterm, 100 for homeworks and 100 for the final. Students who achieve at least 90% are guaranteed to receive an A. A score of at least 80% will receive at least a grade of B. A score of at least 70% will receive at least a C, and students with scores at 60% or above will be assured of passing. Depending on the score distribution, these cutoffs may be lowered. Some discretion may be used in deciding borderline cases, based on my subjective judgment of students' effort and performance.
